Participant Agreement and Release Form

As a participant of the Bunking with the Butterflies Overnight program (the "Program") provided by the Chicago Academy of Sciences / Peggy Notebaert Nature Museum (the "Museum"), I hereby agree that:

- The Museum shall have exclusive right to establish and modify standards of safety, conduct and behavior of all participants in the Program, and requires strict compliance with the standards as a condition for continued participation in the Program.
- The Museum and the Chicago Park District and their respective affiliates, officers, trustees, members, employees, volunteers, contractors and other individuals acting on its behalf (collectively, the "Releasees"), are hereby released, indemnified and held harmless by the participant (and his/her parent/guardian) from and against any and all claims, demands, actions, complaints, lawsuits or other forms of liability arising out of or in connection with the activities of and the participant's participation in the Program or presence on the Museum premises, whether or not caused by the negligence of the Releasees. This release includes, but is not limited to, any injury or loss sustained during or from participation in the Program. This release will apply to the above-mentioned releasing and released parties, and their respective heirs, executors, legal representatives, successors and assigns.
- The participant (and his/her parent/guardian) represents and warrants to the Releasees that he/she in good physical condition and has no medical condition that would make attending the Program hazardous. In case of a medical emergency, the participant (and his/her parent/guardian) hereby authorizes the participant to receive medical care and transportation in order to obtain treatment as employees, contractors or volunteers of the Museum or medical professionals deem appropriate and understand that the release above extends to any liability arising out of or in connection with any such medical treatment or transportation. Also, it is understood that neither medical nor health insurance coverage is supplied by the Museum and that the participant is responsible for all insurance coverage.
- It is understood that video production and/or photography may be conducted during the Program. Participants fully grant to the Museum and those acting under its permission or upon its authority, the unqualified right and permission to reproduce, copyright, publish, or otherwise use the participant's photographic likeness in Museum advertising, marketing or promotional materials and irrevocably consent thereto. It is understood and agreed that no monies or consideration in any form will become due to the participant at any time because of such use of their photographic likeness.
- It is understood and agreed that the Releasees are not responsible for any personal item or property that is lost, damaged or stolen while participating in the Program.
